Our Statement

Tetra Tech International Development condemns all forms of human rights abuses, including modern slavery practices. We recognise our role in protecting the human rights of all people involved in, or impacted by, our business practices. We acknowledge modern slavery as a business risk for every industry and seek to take meaningful steps to identify and address those risks by maintaining responsible and transparent supply chains.

Tetra Tech welcomed the introduction the *Modern* Slavery Act 2018 (Cth) (Act) and the opportunity to provide a modern slavery compliance statement (Statement). We believe that, globally, all businesses are likely to be affected by modern slavery issues either directly or indirectly. Through engaging in honest and collaborative dialogue within and across industry sectors, we can fully understand the exploitation and abuse that characterise modern slavery and raise awareness throughout the supply chain.

As prescribed by the Act, our Statement comprises the following:

- » the reporting entities covered by this Statement;
- » our company structure, operations and supply chains;
- » modern slavery risks in our operations and supply
- » the actions we have taken to assess and address those risks, including due diligence and remediation processes;
- » how we assess the effectiveness of such actions:
- » our process of consultation with our subsidiary entities; and
- » other information that we consider relevant regarding our efforts to combat modern slavery in our operations and supply chains.

Reporting entity, period and approval

This Statement is the first mandatory statement provided by Tetra Tech International Development Pty Ltd (ACN 007 889 081) under the Act and is an individual Statement covering the financial year ending June 2020.

This Statement was approved by the Board of Directors as the principle governing body for Tetra Tech International Development Pty Ltd on 12 July 2021 and is current as at the date of publication.



For FY19-20 we identified 512 individual suppliers of which 233 were private companies or intuitions. The remainder of our supply chain comprised of individual consultants or subcontractors. We identified the majority of our supply chain was distributed between Papua New Guinea (32%) and Australia (32%).

Identifying risks in our supply chain

Methodology

As a general approach we sought to understand our operational and supply chain risks by categorising our annual spend into industries which could be assigned a risk level. To ascertain the risk level for each industry, we undertook our own in-house research to develop a clear picture of the industry specific risks across the Asia Pacific region.

By country, we opted to use the prevalence rating system developed in the Global Slavery Index 2018 (GSI) as the primary risk rating system for our operating countries.

We undertook the assessment in three phases:

- » Phase 1 Supply Chain Categorisation
- » Phase 2 Region Specific Research
- » Phase 3 Risk Assessment

Phase 1 - Supply Chain Categorisation

For the supply chain categorisation, each of our projects categorised every transaction for FY19-20 into an appropriate industry. The industry choice was based on the Global Industry Classification Standard (GICS) developed by the Standard and Poor's Financial Service LLC. This gave us a clear indication of our annual spend into each industry by project, an overall snapshot of the business' supply chain as a whole and set the conditions for Phase 2.

Phase 2 - Region Specific Research

Tetra Tech International Development undertook its own research into the modern slavery risks that focused on identifying key risk types and key risk industries by country. This information was then used to build a risk rating by industry that would be used in Phase 3 to undertake a comprehensive risk assessment across our entire supply chain and operational scope.

Phase 3 - Risk Assessment

The assessment of risk our supply chain was done by comparing the annual spend (by industry) to the risk rating by industry determined in Phase 2.

Risks in Modern Slavery Practices

Regional Overview


Tetra Tech International Development acknowledges modern slavery continues to be present across the Asia-Pacific region where 24.9 million people are estimated to be currently in some form of slavery. Similarly, many of the countries in which we operate such as Fiji, Indonesia, Papua New Guinea, Tonga, Cambodia, and the Philippines have well documented evidence of modern slavery practices. While there has been considerable progress among the regions developing countries, persistent factors that drive human deprivation such as poor economic and social opportunities along with porous geographical boundaries and conflicting geopolitical agendas contribute to high proportions of regional modern slavery and human insecurity. While we operate across the region, our exposure to identified modern slavery risk sectors and locations is concentrated in few key areas. This assessment of increased risk remains largely indirect and predominantly associated with the level of expenditure into reported high-risk industries rather than evidenced on our direct interaction with modern slavery practices.

Risk assessment


All of Tetra Tech International Development's team members are directly employed and work on contracts under highly visible conditions. This significant lowers modern slavery risks within our direct teams across both the corporate and project offices. In addition, as our primary operations are delivery of Australian government aid programs, our practices are heavily regulated by government policies which further reduces the risk our operations directly cause or contribute to modern slavery.

Our risk assessment therefore focused primarily on supply chain analysis. Though we are required to follow government procurement process for nearly all of our supply chain and implement a supplier code of conduct, given the large amounts we spend into key industries in high risk countries, we have assessed there is potential to indirectly support modern slavery practices where it may not be immediately apparent.

Constructions & Engineering in Papua New Guinea

In FY19-20, Tetra Tech International Development's involvement in Papua New Guinea centered on delivering increased educational opportunities while also providing access to infrastructure funding for construction projects across the country. Many of these construction initiatives were focused on achieving improvements in health, education, transportation, governance, and agriculture. 13% of total spend for the business was spent in the construction and engineering in Papua New Guinea.

Despite no indication or evidence that any funding or activity has directly contributed to modern slavery in Papua New Guinea, the high proportion of expenditure in construction-related goods and services across the construction or agriculture sectors increases the accumulative risk of an indirect contribution to modern slavery practices.



Hotels and Restaurants in Fiji

Tetra Tech International Development continues to operate projects across Fiji that aim to drive capacity-building activities that improve health, education, and governance outcomes. While these initiatives are diverse and involve a high degree of direct people-to-people interactions, we believe that these represent a low-risk to aiding modern slavery practices.

However, in-country operational expenditure over FY19-20 identified that significant proportions of spending was concentrated in sectors that represent an increased risk to modern slavery abuse such as hotels, restaurant and leisure, commercial services and supplies, and road and rail transportation. Our analysis reflects reporting that local criminal networks have frequently utilized taxis and hotels for forced sexual exploitation of women and children and that commercial domestic work continues to be a source of forced labour practices involving local and trafficked workers.

Risk Mitigation and Mediation

Mitigating risk and the way forward

Tetra Tech International Development has used the results of our supply chain and operations analysis activities to set our clear and actionable goals for building a deeper understanding of, managing and reducing modern slavery risks across our business. Our goals, which include internal and external initiatives will be progressed and implemented over the next 12 months.

Our operations

We have developed a modern slavery policy in conjunction with our parent company, Tetra Tech Coffey Holding, that informs our staff of our expectations in relation to the identification, reporting, management and control of modern slavery risks within our operations. We have also developed a whistle-blower policy that expressly refers to modern slavery a protected disclosure and trained our staff in the application of its requirements.

Moving forward, we will continue to educate our staff about modern slavery by providing awareness training to all staff and specific procedure-based training for staff who engage with our suppliers. This procedure-based training will aim to build a better understanding of modern slavery risk by educating our staff on how we review our supply chain and suppliers, how we engage with medium and high risk suppliers and how we monitor for compliance with our requirements.

Being part of a global company, we will continue to collaborate with other Tetra Tech Group companies internationally to leverage the vast experience across our global development services division. This will ensure our processes are consistent and allow the identification of improvement possibilities.

Our supply chain

To decrease risk in our supply chains we will increase supplier engagement by:

All new suppliers will:

- » be screened using a Modern Slavery Questionnaire (MSQ);
- » be offered commercial terms of engagement that include specific clause regarding their responsibilities in relation to modern slavery.

We will re-assess suppliers who pose a high risk or high potential exposure to modern slavery to:

- » determine if their service is critical to our supply chain and whether an alternate and lower risk supplier may be engaged
- » assist them in modifying their exposure and/or control measures to reduce their level of risk
- » monitor their performance to ensure risks are appropriately controlled.

For critical suppliers identified as high risk, we will work with those suppliers to understand the origin of the risk of modern slavery in their work and offer support to educate their staff regarding modern slavery risk and how to control it.

Assessing Effectiveness

Tetra Tech International Development will continue to work with and screen all new suppliers for modern slavery risks. Our process will include the analysis of the MSQ results year-on-year to identify patterns, emergent risks and priorities for further due diligence. We will evaluate the MSQ responses for high risk suppliers in order to determine root causes.

We will seek to assess the effectiveness of our actions by tracking:

- » the number and percentage of our staff who have attended the required awareness and procedure based training;
- » the number and percentage of suppliers who have been screened;
- » the number and percentage of suppliers who have accepted our code of conduct or implemented their own similar terms;
- » the outcomes of the screening process and the number and percentage of suppliers determined as being low, medium or high risk;
- » the results of audits conducted on suppliers;
- » the results of internal audits conducted to check for our own compliance with requirements;
- » the changes in MSQ responses and summary data over time for suppliers or supplier types;
- » whistle-blower reports/complaints relating to modern slavery risks or potential breaches of our policy of supplier code of conduct; and
- » the investigations and outcomes of investigations of potential or reported breaches.

As part of our commitment to continuous improvement, we will keep our operational teams abreast of progress on the above which will then be reported to our Executive Leadership Team on a periodic basis.

Consultation process

We have worked with other Tetra Tech companies (Tetra Tech International Development (Europe), Tetra Tech Coffey Holding and Eco Logical (Australia)), to understand the learn from their approach to the identification and management of modern slavery risks and to ensure uniformity of approach within the companies over which we have control.
